## Membership Agreement

**Overview:** I hereby apply for membership in Christa's Private Health Club, a faith-based private health association. By submitting this form associated with this membership agreement, I accept the offer to become a member of Christa's Private Health Club and have read and agree with the following Declaration of Purpose, Preamble and Memorandum of Understanding.

**Declaration of Purpose:** The primary work of Christa's Private Health Club is focused on educating and serving members with effective methods and protocols, including but not limited to: natural healthcare, holistic healing practices, or any other natural form of healthcare practice

to protect and improve the physical, mental, emotional and spiritual health of members as well as to support the production and circulation of clean food (soil), air, and water. This includes but is not limited to: grassroots, political, and economic efforts to ensure the protection of our work and the mission of Oneness Ministry.

**Membership:** By consenting to the Membership Agreement provided, members are granted the following *basic* benefits:

- Full access to review and participate in benefits per agreement.
- Guaranteed to respect your privacy and your data will remain in the custody and in the confidential holding of Christa's Private Health Club. All members will be held in strict confidentiality and will remain private from any State Medical Board, the FDA, FTC, Medicare, Medicaid or insurance companies without the previously expressed specific permission granted by the Member.
- Upon request, access to Christa's Private Health Club's Bylaws.
- Membership with Christa's Private Health Club will remain intact unless the member submits in writing their desire to withdraw membership or membership is terminated by Christa's Private Health Club in accordance with bylaws.
- Complaints against a Christa's Private Health Club member must be submitted in writing to Christa's Private Health Club within three months of the incident of complaint. These will be sent to the Person, Committee, or Tribunal designated by Christa's Private Health Club for evaluation and full and fair conflict resolution.
- Further Governing Law and Venue: Disputes or Disagreements

These Terms shall be construed and governed by equitable laws. You agree to take all reasonable steps to resolve any issue directly with the concerned party(ies). If good-faith efforts fail to resolve an issue, you agree and accept that any lawful action or proceeding shall be adjudicated by Peacemaker Equity (PeacemakerEquity.com), and you expressly waive any objection to this venue or any invocation of forum non conveniens (another forum or court is more appropriate). Additionally, in the event of any dispute or claim relating to or arising out of these Terms of agreement (including, but not limited to, any claims of breach of contract, tort, or infringement), Member/manager agrees that all such disputes/claims will be resolved

by means of arbitration or jury decision adjudicated by Peacemaker Equity.

**Preamble:** We believe that the First Amendment of the Constitution of the United States of America, and the Universal Declaration of Human Rights guarantees our members the rights of free speech, petition, assembly, and the right to gather for the lawful purpose of advising and helping one another. It is hereby declared that we are exercising our right of “freedom of association” as guaranteed by the First Amendment and equivalent provisions of the various State Constitutions, which are excepted out of the powers of general government. This means that our ministerial activities are restricted to the private domain only.

We proclaim the freedom to choose for ourselves the types of products, services, protocols, and self-help modalities that we think best. We encourage our members to perform their own research by studying different resources to prevent illness, diseases of our minds and bodies, and for achieving and maintaining optimum wellness. We proclaim and reserve the right to include health options that include but are not limited to: natural healthcare, holistic healing practices, or any other natural form of healthcare protocols practiced or used by any types of healers or practitioners the world over whether traditional or nontraditional, conventional, or unconventional to protect and improve the physical, mental, emotional, and spiritual health of members.

Christa's Private Health Club exists to improve existing life and health circumstances through teaching alternative health awareness and to provide members with the highest quality, supportive content and cutting-edge, effective modalities for prevention. Christa's Private Health Club will recognize any person (irrespective of age, race, creed, gender, sexual orientation or religion) who has been approved as a member and acts in accordance with these principles and policies as a member and will provide a medium through which its individual members may associate for actuating and bringing to fruition the purposes heretofore declared.

By joining Christa's Private Health Club, and/or any website or social media group started by, created by, maintained, or organized by Christa's Private Health Club, I agree to the terms and conditions of the Membership Agreement as follows:

1. This Ministry of members declares that our objective is to allow the Christa's Private Health Club founders and all members with a platform in which to conduct all manner of faith-based private business with Christa's Private Health Club and with other Ministries and Ministry members, keeping all business in the private domain and utilizing the protections guaranteed by

the Universal Declaration of Human Rights (UDHR), the Constitutions to preserve our rights to associate and conduct business in private as a matter of a private contractual relationship.

2. We believe that the Universal Declaration of Human Rights (UDHR), The Constitution For the United States of America, and of the several states, and the Canadian Charter of Rights and Freedoms guarantees our members the rights of free speech, petition, assembly, and the right to gather together for the lawful purpose of helping one another in asserting our rights protected by those Constitutions and Charters in addition to the rights to be free from unreasonable search and seizure, the right to not incriminate ourselves, and the right to freely exercise all other unalienable rights as granted by God and guaranteed by those Constitutions and Charter WE HEREBY DECLARE that we are exercising our right of “freedom of association” as guaranteed by the aforementioned documents and our ministerial activities are restricted to the private domain only and outside of the jurisdiction of government entities, agencies, Trustees, agents, contractors, and other representatives to regulate or interfere with as provided by law.

3. We declare the basic right of all of our members to decide for themselves which Christa's Private Health Club members could be expected to give wise counsel and advice concerning all matters.

4. We expect the freedom to choose and perform for ourselves the types of services, modalities, and protocols that we think best for achieving and maintaining optimum wellness, as well as the freedom to choose for ourselves any types of assistance which may be made regarding law and any other business activity.

5. The mission of Christa's Private Health Club is to provide members with a forum to conduct private affairs between members in the private domain with the protections guaranteed within the aforesaid Constitution and Charter remaining fully intact.

6. Christa's Private Health Club will recognize any man or woman consensually moving from your public to your private capacity (irrespective of age, race, creed, color, gender, sexual preference or religion) who have joined Christa's Private Health Club or any social media group organized, created, or managed by Christa's Private Health Club and is in agreement with these principles and policies as a member of Christa's Private Health Club, providing said person has not been sanctioned or banned by Christa's Private Health Club, and will provide a medium through which its individual members may associate for actuating and bringing to fruition the purposes heretofore declared.

7. Membership to Christa's Private Health Club and any of its groups may be terminated by Christa's Private Health Club Director or their designee, at any time, should they conclude that a specific member is interacting with them or any other members in a way that is contrary or detrimental to the focus, principles, and betterment of Christa's Private Health Club.

I agree this contract began on the date of my joining Christa's Private Health Club. I declare that by joining Christa's Private Health Club and/or Christa's Private Health Club's websites and/or social media group(s), I have carefully read the whole of this document and I understand and agree with it.

I also agree that, should I disagree with any part of this statement, I will immediately provide written notice of termination of my membership here.

### **Memorandum of Understanding**

I understand that any advice given should not be used as a substitute for medical advice from my own doctor. I will consult my own General Practitioner (GP) if I am concerned about my health.

- I understand that within Christa's Private Health Club no doctor-patient relationship exists but only a contract member to member relationship. I have freely chosen to change my legal status as a public person or patient, customer, or client to a private member of Christa's Private Health Club.
- I understand that Christa's Private Health Club is protected by the First Amendment of the U.S.A. Constitution and is outside the jurisdiction and authority of Federal and State Agencies and Authorities. Any and all complaints or grievances against Christa's Private Health Club, any Trustee(s), members or other staff persons will be settled by a Christa's Private Health Club designee, committee, or tribunal and will be waived by the member for the benefit of Christa's Private Health Club and its members. By agreeing to this membership form I agree that I have sought sufficient education to determine that this is my preferred course of action.
- The undersigned (by submitting the form to become a member) understands that all of their records are always strictly private and protected as a member of Christa's Private Health Club and will only be released upon written request of the member. Because the

privacy and security of membership records maintained within Christa's Private Health Club are held to be inviolate by the U.S. Supreme Court, the undersigned waives HIPAA privacy rights and complaint process.

- Christa's Private Health Club does not participate in any medical insurance plans or collections on behalf of the member but will provide a suitable invoice for the member to pursue reimbursement by his/her insurance company, if applicable.
- Other aspects of informed consent will take place in my discussions with the providers and fellow members of Christa's Private Health Club.
- As I am voluntarily choosing this method of natural health and wellness care, other support, and/or consulting services and activities, I will not hold Christa's Private Health Club or its members financially liable for any particular outcome regarding my health.
- I agree to discuss my concerns with Christa's Private Health Club members and to seek appropriate medical treatment should the need arise.
- I understand that no one within Christa's Private Health Club is acting in the capacity of a doctor, psychologist, or other licensed or registered professional.
- I understand that no one within Christa's Private Health Club is providing health care or medical services that will diagnose, treat, or cure in any manner whatsoever, any disease, condition or other physical or mental ailment of the human body.
- I agree to communicate and discuss vitamins, herbs, and/or other supplements with my GP prior to use, especially if I am taking prescribed medications.

I agree to join the Christa's Private Health Club, a faith based private club under common law, whose members seek to help each other achieve better health and good quality of life. My activities within Christa's Private Health Club are a private matter that I refuse to share with the State Medical Board, the FDA, FTC, Medicare, Medicaid, or my own insurance company without my expressed specific permission. All records and documents remain as property of Christa's Private Health Club, even if I receive a copy of them. I fully agree not to pursue any course of legal action against a fellow member of Christa's Private Health Club, unless that

member has exposed me to a clear and present danger of substantive evil, and upon the recommendation and approval of Christa's Private Health Club.

I enter into this agreement of my own free will without any pressure or promise of cure or disease prevention. I affirm that I do not, or will not, as a private member represent any Local, State or Federal agency whose purpose is to regulate and approve products, or to carry out any mission of enforcement, entrapment or investigation and agree to accept membership in the capacity of private member. I have read and understood this document, and my questions have been answered fully to my satisfaction. I understand that I can withdraw from this agreement and terminate my membership in Christa's Private Health Club at any time, and that my membership can and will be revoked if I engage in abusive, violent, menacing, destructive or harassing behavior towards any other member of Christa's Private Health Club. These pages consist of the entire agreement for my membership in Christa's Private Health Club.

I agree to the membership terms outlined above and become a free member of Christa's Private Health Club and will also be eligible to join other aspects of the club which require membership dues or donation for products or services.
